## TERMS OF USE

### AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Hear It Clear Inc. ### RETURN/REFUNDS POLICY

Event Planners and Promoters (Client) and/or Vendor(s), Artists, Freelancers, Transportation Services, and Venues may cancel any event, reservation or bid with no financial penalty by notifying Hear It Clear, in writing to the Hear It Clear Help Desk, by or before four weeks prior to the start date of the contracted event. Any cancellation later than four weeks prior to the event is subject to forfeiture of all deposits paid. Any cancellation for reasons other than the cancellation of the event is subject to the forfeiture of all deposits.. Hear It Clear reserves the right to retain deposits for any canceled performance for credit of future performance with Client. Client agrees to pay full amount of the contract, if engagement is cancelled after Hear It Clear contracted Vendor(s), Artists, Freelancers, Transportation Services, Venues have in any way begun physical execution of this contract.

Within 72 hours of the start day of executing the event, the following are the only acceptable forms of cancellation:

- (1) extreme weather conditions, lightning storms within 5 miles of an outdoor event site, or winds exceeding 25mph for 25 or more minutes while an outdoor stage is deployed
- (2) An Artist, deemed irreplaceable by Hear It Clear Account management, contracts an illness or ailment that is verified by a licensed health professional as unfit to perform.

Vendor(s), Transportation Services, Venues cannot cancel a contract within 72 hours of the start day of executing the event.

An Artist can only cancel a contract within 72 hours of the start day of an event if the Artist, deemed irreplaceable by Hear It Clear Account management, contracts an illness or ailment that is verified by a licensed health professional as unfit to perform. The Artist agrees to pay Hear It Clear 50% of a received or paid deposit on Net 10 terms.

Hear It Clear will assist Event Planner to replace the Artist, or refund the portion of the returned deposit to Event Planner.

### PROHIBITED ACTIVITIES

You may not access or use the Site for any purpose other than that for which we make the Site available. The Site may not be used in connection with any commercial endeavors except those that are specifically endorsed or approved by us.

As a user of the Site, you agree not to:

1. Systematically retrieve data or other content from the Site to create or compile, directly or indirectly, a collection, compilation, database, or directory without
